



### From the Principal

Dear St Mary's College

Just over 150 years ago, seven women travelled from Dublin, Ireland, to found a school for girls. The school, St Mary's College, is the oldest school for girls in South Australia. The women, Dominican Sisters, were courageous and resilient. They were inspired by a commitment to the rigorous education of young women and a vocation to live a gospel centred life.

Fast forward to the current day. We continue to be inspired by the vision of our founding sisters. The Holy Cross Congregation of Dominican Sisters has cared for and carried this work through the decades. Some years ago, in a development that highlights the foresight and courage of our founders, the congregation began the detailed work of establishing Dominican Education Australia and entrusting it with the ongoing education ministry,

The last step in that process was completed recently with the transfer of land for St Mary's College and Cabra Dominican College, from the Congregation to DEA. It was a privilege to join with the leaders of each school, board chairs, DEA Trustees and the leadership of the Holy Cross sisters for a ritual and then signing of the documents.

Bearing witness to this next step in the Dominican Story was a poignant moment in time. The vision of the sisters, over 150 years ago, was that the land on which St Mary's stands always be used for the education and formation of young people. Entrusting this work now to DEA and the respective Boards and Principals ensures it's continuation into the future.

The capacity of this fine group of women to recognise the need for this, rather than to cling to the past, is an inspiration to our community. It reminds me again, that we live inside and continue to tell a truly great story. One that will continue to empower young women through education for many years to come.

## Young People and the Internet

In September of 2020 the eSafety Commissioner conducted a survey of teens aged 12-17. The surveys aim was to gain an understanding of how young people deal with negative online experiences, the types of information they need to stay safe online and the sources they trust online.

The Key findings were:

### Online Lives

- Teens spend an average of 14.4 hours a week online
- 9 in 10 teens used the internet to research topics of interest, watch videos, chat with friends and listen to music
- 8 in 10 teens played games on line with others

### Social Media

- Teens used an average of four different social media services— YouTube, Instagram, Facebook and Snapchat remain the most popular apps/platforms
- TikTok (formerly Musical.ly) has shown the greatest growth, from 12% of teens in 2017, up to 38% in 2020

### Negative Online Experiences

- 44% of teens had a negative online experience in the six months to September 2020
- The top three were being contacted by a stranger or someone they didn't know (30%), receiving inappropriate or unwanted content (20%) and being deliberately excluded from events/social groups (16%)
- More than 80% teens took some form of action after a negative online experience

### Online Safety Information

Three quarters of teens wanted more online safety information delivered through trusted channels including:

- Their school or an online safety class—43%
- A trusted Esafety website—40%
- From a parent/carer—38%

### Positive Online Behaviours

- 9 in 10 teens had engaged in at least one type of positive online behaviour
- Nearly all teens who had a negative experience online engaged in positive online behaviour afterwards.

## Collection Notice for parents/guardians

### 2021 Student Residential Address and Other Information

The Australian Government Department of Education, Skills and Employment (the department) would like to advise you that a request has been made for your child's school to provide residential address and other information as required under the *Australian Education Regulation 2013* (Cth).

The school is required to provide the department with the following information about each student at the school:

- Names and residential addresses of students' parent(s) and/or guardian(s)
- Student residential address (**excluding student names**)
- Whether the student is a primary or secondary student (education level)
- Whether the student is boarding or a day student (boarding status).

Your child's school generates a **unique and unidentifiable** record number for each student record. The number is **only** used by the school for this collection. **It is not allowed to be used for any other purpose.** The number indicates to the department that each record provided is for one student.

#### Purpose of the collection

The Student Residential Address and Other Information Collection (the Collection) informs Australian Government school education policy and helps ensure funding for non-government schools is based on need.

The information collected will be used to inform school funding calculations. It is combined with data held by the Australian Bureau of Statistics (ABS) to calculate a non-government school community's anticipated capacity to contribute to the costs of schooling.

From 2020, a new measure of capacity to contribute, the Direct Measure of Income (DMI), was introduced. The DMI is based on the median income of parents or guardians of students at a non-government school using data collected through the Collection. #### Use and disclosure of personal information

**Your personal information is protected by law** under the *Privacy Act 1988* (Cth) (Privacy Act). Personal information is information or an opinion about an identifiable individual. Personal information includes an individual's name and contact details.

Any use or disclosure of your personal information must occur in accordance with Privacy Act and the *Australian Education Act 2013* and *Australian Education Regulation 2013*.

Your personal information provided to the department through the Collection may be:

- disclosed to the ABS for the purposes of capacity to contribute calculations and analysis as a part of the Multi-Agency Data Integration Project (MADIP). Further information about MADIP can be found on the [MADIP page](#) on the ABS website.
- disclosed to a contracted auditor where the department may from time to time, carry out an audit of a school's submission to the Collection. The contracted auditor compares the school's submission with the student enrolment information held by the school and will not use the information for any other purpose
- disclosed to its service providers for the purposes of the provision of information and communications technology support services to the department
- used or disclosed where it is otherwise required or authorised by law.

The department does not intend to disclose your personal information to any overseas recipients.

The department's privacy policy can be found at [www.dese.gov.au](http://www.dese.gov.au) and includes information on:

- how individuals can access and seek correction of the personal information held by the department;
- how complaints about potential breaches or breaches of the Privacy Act can be made;
- how the department will deal with these complaints.

The department commissioned an independent privacy impact assessment (PIA). The PIA assesses the flows of information under the Collection, compliance with the Privacy Act and measures in place to safeguard the personal information being collected. ### What do you need to do?

You are not required to do anything. Your school is responsible for providing the requested details to the department; however, you may wish to ensure that your school has the most up-to-date and correct details for your family.

## Traffic Safety

I would like to communicate some important reminders and requests regarding traffic safety and awareness. Observations and parental feedback have indicated some dangerous driving behaviours which compromise student and community safety particularly in Franklin Street at the beginning and end of the day.

We ask that all community members follow the simple manageable requests below which are based on traffic safety guidelines from Adelaide City Council and the need to prioritise community safety over individual need.

**PLEASE** do not park your vehicle in the Drop Off/Pick Up Zone adjacent to the main gates between 8.00 and 9.00 am and 3.00 and 4.00 pm.

- You must **not** stop in a **NO STOPPING** Zone, even for a few seconds to pick up your child.
- You **may** stop in a **NO PARKING ZONE** for a few seconds to pick up a child who is waiting nearby. You must **not** park or leave the vehicle.

**PLEASE** do not double park on the outside of parked vehicles – this is dangerous and blocks the bike lane.

**PLEASE** consider delaying your arrival to collect your daughter at the end of the day by **5/10 minutes**.

**PLEASE** understand that it is not possible for all parents to collect their daughters at 3.15 pm outside the main gate.

**PLEASE** drive around the block if necessary.

**PLEASE** consider parking a little further away and allowing yourself/your daughter to walk.

**PLEASE** model responsible behaviour by always using the pedestrian crossing to cross Franklin Street.
